

**AMENDMENT #4

Effective January 1, 2023, the Northwestern Medical Center NMC Plan is amended as follows (red and *italics* means change or addition and ~~strikeout~~ means deletion):

Within "SCHEDULE OF MEDICAL BENEFITS", "NON-AMBULANCE TRAVEL BENEFIT" is replaced as follows and "TRAVEL REIMBURSEMENT BENEFIT" is added alphabetically as follows:

<p><b>Benefit Limits:</b> \$5,000 Maximum Benefit per Transplant or per course of treatment for Congenital Heart Disease, limited to:  Coach airfare.  If driving, IRS standard mileage rate reimbursement.  Meals limited to \$50 per day per person.  Lodging not to exceed \$125 per day.</p> <p><b>This benefit is available to the patient and one companion, or two companions when the patient is a minor.</b></p> <p><i>This benefit is separate from and cannot be used with the Travel Reimbursement Benefit</i></p>		
<b>TRAVEL REIMBURSEMENT BENEFIT</b>		
	100%, Deductible Waived	
<p><b>Benefit Limits:</b> <i>\$5,000 Maximum Lifetime Benefit limited to:</i>  <i>Coach airfare.</i>  <i>If driving, IRS standard mileage rate reimbursement.</i>  <i>Meals limited to \$50 per day per person.</i>  <i>Lodging not to exceed \$125 per day.</i></p> <p><b><i>Benefit is available only in the event a Covered Person is unable to access Network health care services covered under this Plan which cannot be accessed within 100 miles (using Google Maps) of the Covered Person's home address.</i></b></p> <p><b><i>This benefit is available to the patient and one companion, or two companions if the patient is a minor, limited to travel to a Network provider.</i></b></p> <p><i>This benefit is separate from and cannot be used with the Non-Ambulance Travel Benefit.</i></p>		

Within "GENERAL PLAN EXCLUSIONS AND LIMITATIONS", as amended, item 14 is replaced as follows:

14. Charges for travel Expenses Incurred by any person for any reason, except as specifically covered under the Non-Ambulance Travel Benefit *or Travel Reimbursement Benefit.*

Nothing in this amendment is deemed to change any other provision of the Summary Plan Description of which it becomes a part.
